As a former prosecutor in Burlington County, she has dealt with all different types of cases, including those involving domestic violence. "Unfortunately, it's very prevalent in our society. It doesn't follow socioeconomic boundaries at all. People think it only happens in certain places but it

happens everywhere. It just happens behind closed doors so it's easier for victims and abusers to hide it."

Smith handles divorce cases involving domestic violence with keen sensitivity saying, "My experience as a prosecutor has equipped me with a real understanding of the cycle of violence. Sometimes it's hard for people to understand that a victim is going to leave their abuser multiple times and still go back. It's

rare for them to leave the first time and not return because the abuser is often able to woo them back with an apology and promises of 'it's never going to happen again', and it continues, which makes it a cycle. It is very hard for the victim to finally leave for good."

Throughout the world, the number of couples seeking divorce has spiked dramatically over the last two years. WKS has certainly seen an increase in divorce cases during this time but has not missed a beat, ensuring clients' concerns are addressed and their needs are met. "Our firm has been really busy throughout the pandemic. Due to COVID concerns, we are still not back in court yet; a lot of our cases have been handled through Zoom. However, we have figured out ways to still be able to efficiently handle and move each of our cases along." That resourcefulness as well as the collaborative efforts of the litigators helps smooth the often-bumpy road of divorce.
